* I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.

I hereby release and agree to hold J&R Basketball harmless from, and waive on behalf of myself and my child any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused. I understand that this release discharges J&R Basketball from any liability or claim that I or my child may have against J&R Basketball with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise. This liability waiver and release extends to basketball conditioning, practices and games.
